



Solicitation of Public Comment
Proposed Rate Request for Bankers Life and Casualty Company
Medicare Supplement Insurance

Bankers Life and Casualty Company (Bankers) has filed with the Office of the Health Insurance Commissioner its proposed rates for its closed block of standardized Medicare Supplement policies sold in Rhode Island. They propose rate increases to be effective January 1, 2020 that vary by plan.

- 585 Rhode Island subscribers
- Anticipated nationwide lifetime loss ratio: average of 69.0%, varies by plan from 65.6% to 93.2%. Rhode Island experience is not considered credible.
- Average rate increase of 5%, ranging from 0% to 5% by plan.
 - Plan A: 5%
 - Plan B: 5%
 - Plan C: 5%
 - Plan D: 5%
 - Plan E: 5%
 - Plan F: 5%
 - Plan FH: 0%
 - Plan G: 5%
 - Plan J: 5%
