Guide to COVID-19 Testing & Vaccines

Rhode Islanders have several no-cost options for getting tested, and for scheduling a COVID-19 vaccination, even if you do not have insurance

• Who Can Receive the COVID-19 Vaccine in Rhode Island?

COVID-19 vaccinations have begun to be administered to eligible Rhode Islanders. The state is distributing the vaccines as safely, quickly, and equitably as possible. Since the initial supply of the vaccine is limited, Rhode Island is using an age-based approach and ensuring the most vulnerable populations receive the vaccine first. All Rhode Islanders 65 and older are now eligible to schedule a vaccination. Health care workers, first responders, and other select groups are also eligible. <u>Click here</u> to see approximately when your age group will be eligible to schedule a COVID-19 vaccine.

Is There a Waitlist for Rhode Islanders Not Yet Eligible?

Yes! Rhode Islanders who are not yet eligible for vaccinations can add their contact information to a Vaccine Information Notification List to get updates as eligibility opens to new groups. To enroll in this list, go to <u>portal.ri.gov</u>.

• How Do I Schedule a COVID-19 Vaccination?

If you are eligible to be vaccinated, there are three different options: State-run vaccination centers, designated local pharmacies, and other local and regional vaccination sites, like clinics run by cities and towns, some hospitals, and community health centers. To register for an appointment, go to <u>vaccinateRl.org</u>, or call the automated line: 844-930-1779.

• Do I Need to Pay for the COVID-19 Vaccine?

There is no cost or co-pay for the COVID-19 vaccine. Insurance companies may be charged, but you will not be. Those without health insurance will also receive the COVID-19 vaccine at no cost.

• How Do I Sign Up for a COVID-19 Test?

There are several ways to get a COVID-19 test:

Any Rhode Islander can schedule a no-cost COVID-19 test at one of the state COVID-19 test sites. Go to <u>portal.ri.gov</u> to sign up. To view a list of all of the state COVID-19 test sites, <u>click here</u>.

Call your primary care provider or child's pediatrician. Ask if they do point-of-care testing or if they can schedule a test for you.

Make an appointment at a <u>respiratory clinic</u>.

• Do I Need to Pay for a COVID-19 Test?

All Rhode Islanders, with or without insurance, can schedule a no-cost COVID-19 test at a state COVID-19 testing site. The State of Rhode Island will cover the cost of COVID-19 testing for anyone without insurance who schedules on <u>portal.ri.gov</u>. There may be costs associated with testing at other testing sites that are not operated by the state.

How Do I Get My Test Results?

You can access your results at <u>portal.ri.gov/results</u> within two to four days after your test. Rapid test results are usually posted to this portal in the same day. To access this portal, you must enter your personal information and the date you were tested.
