HEALTH INSURANCE ADVISORY COUNCIL

The Health Insurance Advisory Council (HIAC), plays a critically important role in OHIC's ongoing work, as it brings forth diverse consumer, business, and provider voices from across Rhode Island. At its core, the council exists to obtain information and present concerns to the health insurance commissioner from consumers, businesses, and health care providers affected by commercial health insurance decisions. In partnership with this council, our office is focused on making Rhode Island's health care system more affordable, accessible, and equitable for consumers. Each month members strive to find innovative and sustainable approaches to advise and support the office's work. This month we are highlighting the council's vital function in advising OHIC's ongoing work to transform the health care delivery system in Rhode Island.

REPRESENTING RHODE ISLAND

In an effort to better represent Rhode Island communities with more diverse voices from across the state, the Health Insurance Advisory Council sought out new advisory council members in 2021, and is continuing to do so today. Creating an equitable health care system in the state can only be achieved when all Rhode Islanders, from every background, have a voice at the table to influence changes in policy and regulations. OHIC and HIAC are committed to efforts to ensure that the health care system functions in a manner that is just, regardless of one's race, ethnicity, disability, gender identity, sexual orientation, socioeconomic status, geography or any other social barrier/factor. The council aims to be represented by three core interest groups: consumer advocates, health care representatives, and small business owners. Currently, we are looking for another consumer advocate to join the council. COLLABORATING TO LOWER HEALTH CARE COSTS

Health Insurance Advisory Council members understand the importance of collaboration with health care stakeholders, and, more importantly, the Rhode Island individuals and small businesses that are affected by commercial health insurance. Throughout the year, in addition to reviewing policy reform proposals and regulatory enforcement activities, the council invites presenters from advocacy organizations, other state agencies, and the public to engage in meaningful conversations about the state's health care system. Public input and collaboration with local business and consumer advocates is the most important aspect of HIAC meetings. Hearing the voices from the community we serve helps to highlight the critical health insurance concerns that need to be addressed by the council, and by OHIC and is the strongest pathway to eliminating health care barriers.
