STATUS

- Phase 2 will broaden scope of services reviewed in Phase 1
- Key informant interviews will be continued on an as-needed basis

Fee Schedule Benchmarking Example #1

Differences in billed unit type

Massachusetts Early Intervention program defines the billable unit for an intake screening as 15 minutes.

Procedure Code	Service Description	Unit	Rate Per Unit
T1023	Intake/Screening - an initial face-to- face meeting of a member and a member's caregiver with professional program staff to initiate the process of evaluation of eligibility and enrollment in the early intervention program	15 Minutes	\$29.49

Rhode Island Early Intervention program defines the billable unit for an intake screening as per visit.

Procedure Code	Service Description	Unit	Rate Per Unit
T1023	Intake - screening to determine the appropriateness of consideration of an individual for participant in a specified program, project or treatment protocol	Visit (max 90 minutes)	\$157.32

Normalizing unit types of comparable procedure codes across programs may be required in fee schedule benchmarking

Fee Schedule Benchmarking Example #2

Covered services

Massachusetts Early Intervention program utilizes procedure codes 96164 and H2015 for health behavior intervention and comprehensive community support services.

Procedure Code	Service Description	Unit	Rate Per Unit
96164	Health Behavior Intervention Group	30 Minutes	\$14.74
H2015	Comprehensive community support services	15 Minutes	\$25.28

Rhode Island does not utilize the 96164 or H2015 procedure codes in any of their program fee schedules.

These services may not be covered by Rhode Island's early intervention program. Contact with a program manager may be required to identify whether similar services are covered in other programs.

Certain services may not be equally covered across payers, or use of varying procedure codes may require additional research to identify comparable services.

Rates with tiered reimbursement

Massachusetts Early Intervention program has only one rate for assessments regardless of the practitioner type.

Rhode Island Early Intervention program varies payment based on the practitioner type.
