

Data Measurement



DEFINE DATA

Define the necessary data:

- Rate of prior authorizations per insured member
- Prior authorizations approved vs prior authorizations approved with modification
- Method of reporting the service codes that require prior authorization by plan

COLLECT DATA

Collect defined data from commercial insurance companies in order to compare and analyze. Potentially by way of forming a short-term data workgroup.


ANALYZE

Analyze the collected data from commercial insurance plans to draw conclusions for recommendations of reduction.

REDUCE

Use analyzed data to determine recommendations for reduction of services that require prior authorization.
