# OHIC Social and Human Service Programs Review Updates

## 2025 Independent Rate Model (IRM) Surveys

- OHIC/Milliman sent out provider surveys in mid-January with a completion due date of March 14, 2025.
- In May, provider workgroup meetings will be held to discuss and set rate assumptions.
- In June and July, providers will have an opportunity to review draft rates and provide feedback.
